

EXPRESSION OF INTEREST FOR THE PROVISION OF OCTG REPAIR SERVICES AND LICENSEE MACHINE SHOP RIGS FOR TILENGA CA-1 & LA-2 NORTH WORKOVER CAMPAIGN REFERENCE: CTR096250

TotalEnergies EP Uganda (COMPANY), in its capacity as Operator of Contract Area (CA) 1 and License Area (LA) 2, in conjunction with its Joint Venture partner(s), invites experienced and qualified companies/entities to express interest in the provision of OCTG repair services and licensee machine shop for Tilenga CA-1 & LA-2 North Workover Campaign in Uganda.

General Field Development Description:

The Tilenga oil and associated gas development is located in the Northern area of Lake Albert in Uganda and covers the fields in CA-1 block and the Northern part of LA-2 block (Tilenga Project).

The major development surface facilities include the following:

- Wellpads (31) and the upstream gathering network.
- The Industrial Area containing temporary facilities and the Central Processing Facility (CPF).
- The associated supporting infrastructure (camps, roads, aerodromes etc).

Scope of Work:

COMPANY intends to issue a future Call for Tender for the provision of OCTG repair services and licensee machine shop for damaged tubulars/casings during Drilling operations and workovers to be performed during the life of the Field for Tilenga CA-1 & LA-2 North Workover Campaign in Uganda.

Following requirements to be demonstrated:

- Ability to repair (cut and thread pin and replace box with new) the following tubular sizes (Outer Diameter): 10 ¾" casing, 7 5/8" casing, 4½" tubing, 4" tubing, 3 ½" tubing. Ability to manufacture pup joints and crossovers from existing R3 or R2 joints.
- Required Licenses/Certification:
 - o Mandatory: BTC, VAMTOP, DINOVA, API Q1 10th Edition (ISO 9001:2015 is optional), CNC programs under license by OEM
 - o Optional: HSM-2, JFEBEAR, API 7-1 AND 7-2 FOR API drilling connections & practices, API 5CT/5DP
- Qualified Personnel: trained and certified to cut and thread

connections, to replace box, and to perform all handling tasks associated with OCTG repair and pup joints / crossovers manufacturing.

- Organisational, Technical, HSE, and financial requirements to set-up and operate the Licensee machine shop to provide the above-mentioned services, compliant with industry & COMPANY standards.

COMPANY seeks to identify a company possessing or capable of providing OCTG repair services and licensee machine shop, for damaged tubulars/casings and manufacturing of pup-joints and crossovers from existing R3/R2 joints, during Drilling operations and workovers operations to be performed during the life of the Field. The supplier shall comply with COMPANY's technical requirements to perform efficiently the operations. It must consider environmental constraints and establish a licensed workshop within the proximity of the Industrial Area. Potential bidders shall be encouraged to submit bids with license and efficient technologies, proposed to achieve COMPANY's requirement and objectives.

Interested parties (individual firms or proposed partnerships) shall, as a minimum, be required to demonstrate the following:

1. Proven experience in either repair, fabrication services of OCTG for an international oil company or major operator.
2. A plan to obtain the required license to thread the licensed connections listed above.
3. Demonstrated commitment to statutory National Content requirements for oil and gas operations.
4. Current registration to; or application to be registered to; the National Supplier Database for the year 2024.
5. Proof of being suitably resourced with personnel with substantial qualifications and experience in the required services.
6. Proof of good financial solvency to deliver the services required.
7. Proof of appropriate Quality, Health, Safety, Social, Security and Environment policies, procedures, and processes in compliance with applicable national and industry standards.
